**Comments on Inspection:** Well sign should be located within 50 feet of wellhead (Rule 19.15.16.8). NEED TO MOVE WELL SIGN FROM ENTRANCE TO LOCATION TO WITHIN 50 FEET OF WELLHEAD. 1st notice. MW

Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well.
