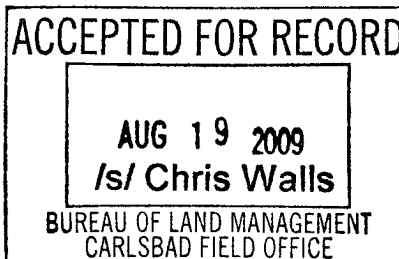
13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. NMOCD will not grant a Vent or Flare Permit for the subject well. We have contracted an Odessa, Texas firm to manufacture a 2 stage beam compressor in order to produce the subject well's minimum casing head gas production against 400-600 psi sales line pressure. This installations is scheduled for August 17, 2009. We have kept the well shut-in waiting on compressor construction since the 14th of July, 2009 so as to abide by NMOCD rule 19.15.18.11. We will submit a sundry notice notifying BLM of production start-up with this new equipment after it has been installed and running.
