- 2 - G-M Haul-off bins with track system
- 1 – 500 BBL frac tank for fresh water
- 1 – 400 BBL open top tank for liquid waste

Operations and Maintenance:

Closed loop equipment will be monitored while drilling. Any necessary maintenance will be performed as needed. Drill cuttings and waste will be hauled to G-M when bins are filled.
