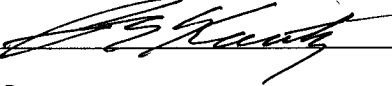

Closed Loop Design

The closed-loop will be designed with augers at the bottom of the mud tank to transfer the solids into a centrifuge system at the end of the tank. The drilling fluid is recycled back to the tanks for re-use. Solids from the centrifuge go to the shale bin (haul-off bin) and the fluid is recycled back to the tank. Solids will be hauled off to an OCD approved disposal site.

Operating and Maintenance Plan

The closed-loop system will have 24-hour supervision to prevent spillage and leaks. The drilling fluid will be recycled during drilling operations and the drill cutting transferred to a haul-off bin for removal to an approved OCD land farm. After drilling operations, all drilling fluids will be taken to an approved OCD disposal site.
