Dear Operator:

Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.

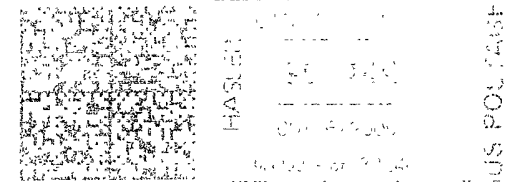
