Tubing and tools stuck x Chemical cut tubing at 7510ft x CIBP at 7491ft capped with 35ft cement

Propose to PA as follows:

1. Load hole with gelled brine
2. Cut and pull 4 1/2" casing from 5380ft
3. M&P 35sack cement plug at 5500ft x stub plug x WOC and tag
4. M&P 25sack cement plug at 3657ft x Intermediate casing shoe x WOC and tag
5. M&P 25sack cement plug at 2370ft x Base of Salt
6. M&P 25sack cement plug at 1890ft x Top of salt
7. Perf 7 5/8" casing at 450ft x Circulate cement to surface
8. Install PA marker x clean and restore location

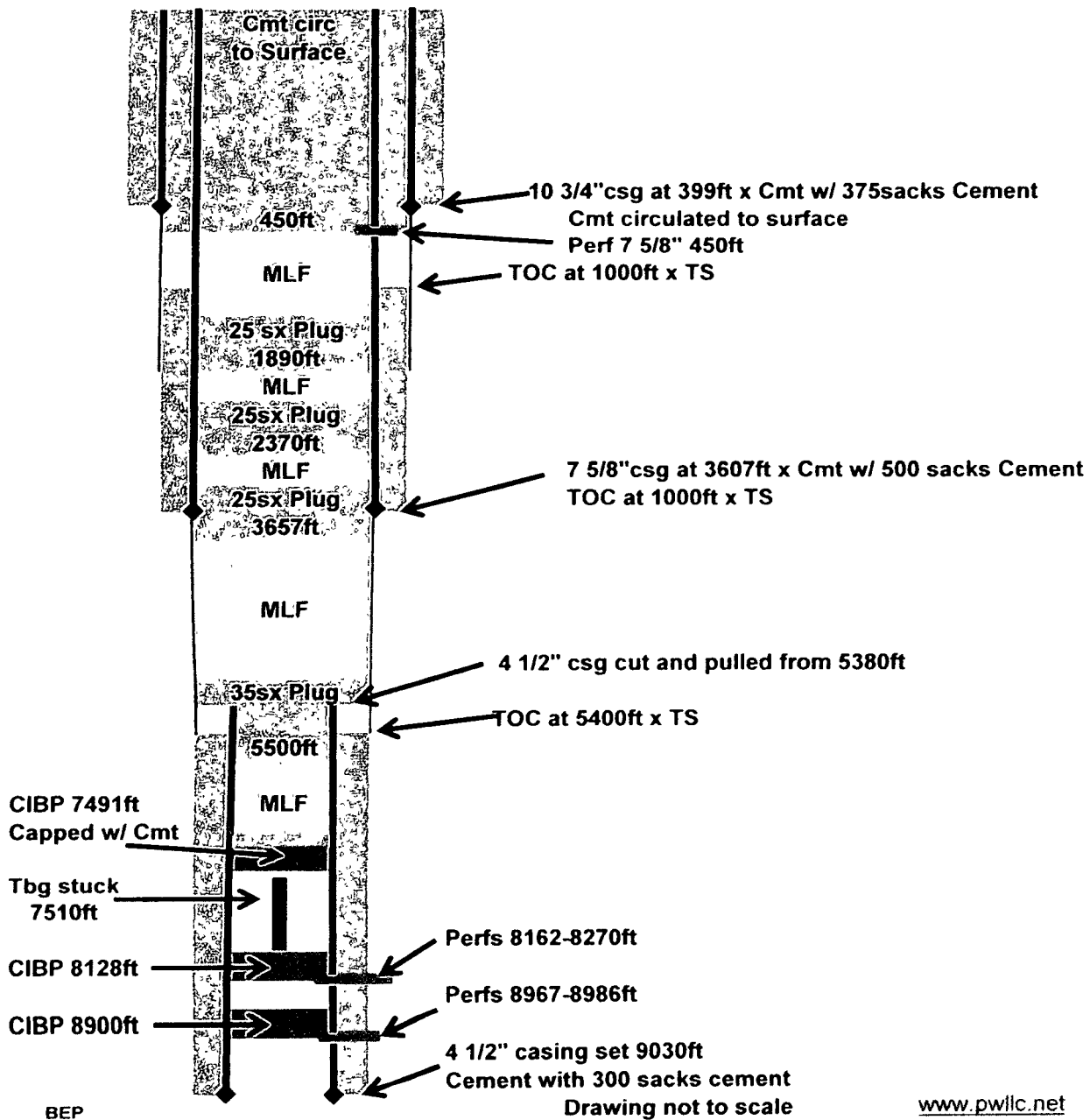
