Dear Operator:

The Oil Conservation Division (OCD) is in receipt of your Form C-104 Request for Allowable and Authorization to Transport Oil and Gas for the above-identified wells.

Rule 19.15.16.19.A NMAC provides the OCD may assign an allowable to a newly completed or re-completed well or a well completed in an additional pool or issue an operator authorization to transport oil or gas from the well if, among other things, the operator is in compliance with Subsection A of Rule 19.15.5.9 NMAC.

Subsection A of Rule 19.15.5.9 NMAC states in relevant part:

- A. An operator is in compliance with Subsection A of 19.15.5.9 NMAC if the operator:
- (4) has no more than the following number of wells out of compliance with 19.15.25.8 NMAC that are not subject to an agreed compliance order setting a schedule for bringing the wells into compliance with 19.15.25.8 NMAC and imposing sanctions if the schedule is not met:
 - (a) two wells or 50 percent of the wells the operator operates, whichever is less, if the operator operates 100 wells or less;
 - (b) five wells if the operator operates between 101 and 500 wells;
 - (c) seven wells if the operator operates between 501 and 1000 wells;
 - and
 - (d) 10 wells if the operator operates more than 1000 wells.

OCD records currently show Pride Energy Company (Pride) as operator of record of 71 wells. As operator of record of 71 wells, Pride would be in non-compliance with Subsection A of Rule 19.15.5.9 NMAC if it has more than 2 wells on the Inactive Well List. Pride currently has 6 wells on the Inactive Well List.¹ Therefore, Pride is in non-compliance with Subsection A of Rule 19.15.5.9 NMAC.

Because Pride is in non-compliance with Subsection A of Rule 19.15.5.9 NMAC, Pride's Form C-104 Request for Allowables and Authorization to Transport Oil & Gas for the above-identified wells is hereby DENIED.

You may re-submit your Form C-104 Request for Allowables and Authorization to Transport Oil & Gas for the above-identified wells once you have come into compliance with Rule 19.15.5.9 NMAC.

To come into compliance with Rule 19.15.5.9 NMAC your company must reduce the number of wells on the Inactive Well List to no more than 2. A well will be removed from the Inactive Well List when the operator takes one of the following actions:

- 1) plugs the wellbore and files an approved C-103 documenting the actual plugging;
- 2) places the well on OCD-approved temporary abandonment status;
- 3) returns the well to production or other beneficial use and files a C-115 documenting the production or use; or
- 4) enters into an Agreed Compliance Order with the OCD covering the well.

An Agreed Compliance Order sets a schedule for returning the operator's inactive wells to compliance and imposes a penalty if the schedule is not met. If you would like to discuss entering into an Agreed Compliance Order for your non-compliant wells, please contact OCD attorney Sonny Swazo at sonny.swazo@state.nm.us or (505) 476-3463. Please be advised that Agreed Compliance Orders are offered at the discretion of the OCD. Some operators may not meet Agreed Compliance Orders eligibility requirements.
