
13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. Required subsequent reports must be filed within 30 days following completion of the involved operations. If the operation results in a multiple completion or recompleat in a new interval, a Form 3160-4 must be filed once testing has been completed. Final Abandonment Notices must be filed only after all requirements, including reclamation, have been completed and the operator has determined that the site is ready for final inspection.)

1. Remove 1'-6 caliche and contaminated soil from site and disposed of at approved site
 2. Replace with 1'-3' of caliche and level as needed
 3. Top entire location with 1'-3' of topsoil as needed
 4. Level and contour to surrounding area
 5. Build earthen berm in front of location to prevent vehicular traffic
 6. Seed all disturbed area with BLM # 2 seed mixture with BLM approved seeder.
