- 11-9-2009 RIH, tag plug @ 925'. POH. RIH & perf @ 405'. POH, RIH & pump 35 sacks. POH WOC, RIH @ tag 228'. POH. RIH & perf @ 60'. Circ to surface in/out w/15 sx. RD. Dug out and cut off wellhead, installed dry hole marker. Clean up loc. All work was conducted using steel pits.


