**FORMAL NOTICE OF LOSS OF INJECTION AUTHORITY**  
**OPERATOR REQUIRED TO CEASE AND DESIST INJECTION**

Re: Patterson Operating and Pumping Inc., OGRID 188566  
Glenn-Ryan Cooperative Waterflood Project

Dear Operator:

The purpose of this letter is to give Patterson Operating and Pumping Inc. (Patterson) formal notice that its authority to inject into the Glenn-Ryan Cooperative Waterflood has terminated. **Patterson no longer has authority to inject into the wells in that waterflood.**

19.15.26.12(C)(1) NMAC provides:

"Whenever there is a continuous one year period of non-injection into all wells in an injection or storage project or into a salt water disposal well or special purpose injection well, the division shall consider the project or well abandoned, and the authority for injection shall automatically terminate ipso facto."

19.15.26.12(C)(2) NMAC provides:

For good cause shown, the director may grant an administrative extension or extensions of injection authority as an exception to Paragraph (1) of Subsection C of 19.15.26.12 NMAC, provided that any such extension may be granted only prior to the end of one year or [sic] continuous non-injection, or during the term of a previously granted extension.

According to Oil Conservation Division (OCD) records, Order R-5675 in Case 6161 allowed two lease waterfloods: the Leonard Brothers Waterflood and the Leonard



Federal Waterflood. A copy of that order is attached. By letter dated November 20, 1991, the OCD consolidated the project into the Glenn-Ryan Waterflood Project. A copy of that letter is attached. The Glenn-Ryan Waterflood Project includes the following acreage:

Township 26 South, Range 37 East, NMPM:  
Section 13: E/2, NW/4, N/2 SW/4, SW/4 SW/4  
Section 14: N/2  
Township 26 South, Range 37 East, NMPM:  
Section 14: S/2.

The OCD researched that acreage and found the following injection wells, all operated by Patterson:

Glenn Ryan #006, 30-025-11985  
Glenn Ryan #008, 30-025-25981  
Glenn Ryan #013, 30-025-25982  
Glenn Ryan #015, 30-025-25857  
Glenn Ryan #019, 30-025-25581  
Glenn Ryan #021, 30-025-25856  
Glenn Ryan #023, 30-025-25561  
Glenn Ryan #030, 30-025-25339

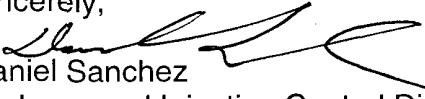
None of these wells is currently reporting injection. None of these wells has reported injection for a period in excess of one year. A copy of Patterson's well list, showing the last reported injection for each well, is attached.

Because all injection in the waterflood ceased for a period in excess of one year, the authority for injection into wells in the Glenn-Ryan Waterflood Project automatically terminated pursuant to 19.15.26.12(C)(1) NMAC. **If Patterson wishes to operate a waterflood in this area or inject into any of the identified wells it will need to apply for a new permit under 19.15.26.8 NMAC. Please note that to be eligible for a permit Patterson must be in compliance with 19.15.5.9 NMAC.**

By copy of this letter, I am notifying the Hobbs District Office that your injection authority for these wells has been terminated.

If you disagree with the OCD's conclusion that the authority to inject in the Glenn-Ryan Waterflood Project has terminated, please provide documentary proof that there has not been a period of one year of non-injection, or that you are operating under an administrative extension of injection authority.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 8 a.m. on May 22, 1968,  
at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 29th day of May, 1968, the Commission, a  
quorum being present, having considered the testimony, the record,  
and the recommendations of the Examiner, and being fully advised  
in the premises,

FINDS:

(1) That due public notice having been given as required by  
law, the Commission has jurisdiction of this cause and the subject  
matter thereof.

(2) That the applicant, Texas Pacific Oil Company, seeks  
permission to institute a waterflood project in the South Leonard  
(Queen) Unit Area, South Leonard-Queen Pool, by the injection of  
water into the Queen formation through five injection wells in  
Sections 13, 23, and 24, Township 26 South, Range 37 East, NMPM,  
Lea County, New Mexico.

(3) That the wells in the project area are in an advanced  
state of depletion and should properly be classified as "stripper"  
wells.

(4) That the proposed waterflood project should result in  
the recovery of otherwise unrecoverable oil, thereby preventing  
waste.

(5) That the subject application should be approved and the project should be governed by the provisions of Rules 701, 702, and 703 of the Commission Rules and Regulations.

IT IS THEREFORE ORDERED:

(1) That the applicant, Texas Pacific Oil Company, is hereby authorized to institute a waterflood project in the South Leonard (Queen) Unit Area, South Leonard-Queen Pool, by the injection of water into the Queen formation through the following-described wells in Township 26 South, Range 37 East, NMPM, Lea County, New Mexico:

(2) That the subject waterflood project is hereby designated the TP South Leonard Queen Waterflood Project and shall be governed by the provisions of Rules 701, 702, and 703 of the Commission Rules and Regulations.

(3) That monthly progress reports of the waterflood project herein authorized shall be submitted to the Commission in accordance with Rules 704 and 1120 of the Commission Rules and Regulations.

(4) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.

Section 14: S/2

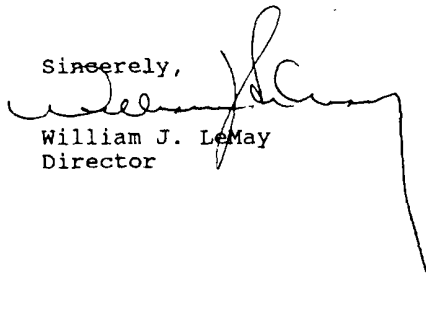
