Cimarex proposes to drill 12½" hole to 3950' and if hole conditions permit, to trip out and drill 8¾" hole to TD and set 7" casing, thereby eliminating the intermediate casing string. If hole conditions do not permit, we will set 9½" intermediate casing to 3950' as permitted. Production casing will be cemented with sufficient sx to reach surface.
