Dear Operator:

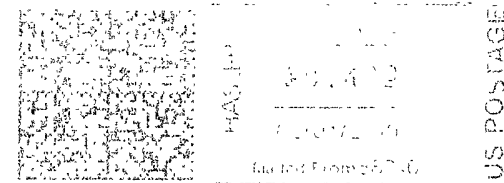
