Operation and Maintenance

Cuttings will be discharged from rig shakers to drying shakers and into 150 bbl cutting tank. Fluid will also be removed from the bottom of the rigs pit system via the torpedo tank and sent to a high speed centrifuge. The remaining solids will be spun out and sent to a 2cnd 150 bbl solid catch tank. Cutting tanks will be visually inspected throughout all tours.

Closure plan

Drilled cuttings will be dipped out of the catch tanks by a backhoe and placed in a suitable transport container (dump truck tank or cuttings bins). Drilled cuttings will be disposed of at a suitable off site waste disposal facility.
