Reactivation of these two wells will facilitate the need for added tanks/vessels and other construction to occur on the existing Lauck Federal production facility.

Additions: 300 bbl steel oil tank, 300 bbl fiberglass water tank, new connections/piping to connect cleanout and repair of existing 500 bbl steel tank - convert to gun barrel

Clean-up of existing environmental issues (stained soil, old connections and piping) - soil will be hauled to land fill and or treated in place, junk connections will be hauled to junk metal bins for recycle.

Burn and fencing will be restored around production facility
