- 08.12.09 After drilling through cement and fiberglass, lost cement, so pumped cement kick off plug from 8982-8266' w/ 250 sx Halcem-H.
- 08.13.09 Kicked off 6 1/2" hole @ 8565.'
- 08.24.09 Reached TD of 6 1/2" hole (MD 13220' TVD 8698'). Began reaming hole.
- 08.28.09 Ran 4 1/2" PEAK 11.6# P-110 BTC from 8361-8875' and LTC from 9053-13061.'
- 08.29.09 Released rig.
