- 1-13-2010 TIH & tag cement @ 501'. TIH & Perf'd @ 403', POH, ran packer & squeezed 35 sx. POH, WOC. TIH @ tag @ 280'. TIH & Perf'd @ 60', circulated 15 sx to surface. Rigged down, dug out and cut off wellhead, installed dry hole marker. Clean location, moved out.
