

PARTIAL RE-ASSIGNMENT OF OIL AND GAS LEASEHOLD ESTATE

Pogo Producing Company LLC, successor to Pogo Producing Company, whose address is Suite 2100, 1021 Main Street, Houston, Texas 77002 (hereinafter referred to as "Assignor"), does hereby re-assign and re-convey to: **Bonnie Resler Karlsrud**, whose address is 840 Crescent Dr., Boulder, CO 80303, an undivided 40.34%; **Wayne Resler**, whose address is 795 Woodland Drive, El Paso, Texas 79922, an undivided 38.36%; and **Jimmy D. Evans and his wife, Linda B. Evans**, whose address is P.O. Box 1855, Eunice, NM 88231-1855, an undivided 21.30% (hereinafter collectively referred to as "Assignee"), of all of its right, title, and interest in and to the Oil, Gas and Mineral Leases (the "Leases") and contractual interests set forth on Exhibit "A" which is attached hereto, located in Lea County, New Mexico, **insofar and only insofar** as said Leases and contractual interests cover and include the rights to any oil and gas that may be produced from the depth intervals defined in the Special Rules and Regulations for the Jalmat Gas Pool, established by the New Mexico Oil Conservation Division (Case No. 12563, Order No. R-8170-P), which are defined in such rules as the depth interval from the top of the Tansill formation to a point 100 feet above the base of the Seven Rivers formation, thereby including all of the Yates formation, **and only insofar** as said Leases and contractual interests cover the following described lands in Lea County, New Mexico, to wit:

Section 20: NE 1/4 SW 1/4


**AND LESS AND EXCEPT THAT** Assignor reserves and retains for itself, and its successors and assigns, all right, title, and interest in and to all other depths not specifically re-conveyed to the Assignee in the above described lands and the wellbore of its Resler "A" Well No. 1, including any surface equipment pertaining to said well, which is located on the lands being re-conveyed herein.
