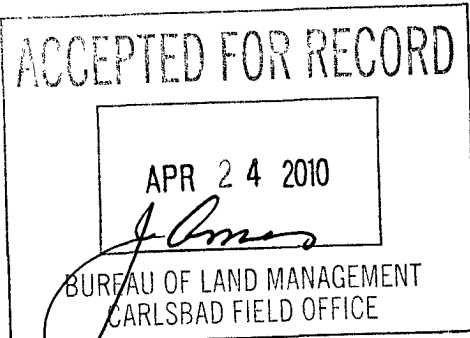
The above location was built and never drilled as of 2/22/1990. The location was reclaimed on May 15, 2009 as follows:

7. Reseeded with BLM # 2 mix
