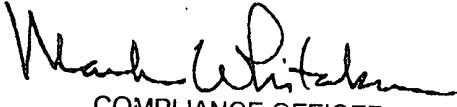
Please notify the proper district office of the Division, in writing, of the date corrective actions are scheduled to be made so that arrangements can be made to reinspect the well and/or facility.

NEED TO REPLACE WELL SIGNS, REMOVE & PROPERLY DISPOSE OF CONTAMINATED SOIL, REPAIR FENCE AROUND BATTERY, AND REMOVE FLUIDS FROM DRUM AT BATTERY. 1st notice.

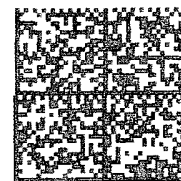
