Penroc Oil Corporation will use a closed loop system in the plug and abandonment of this well. The following equipment will be on location:

2-130 bbl vacuum trucks.

OPERATION AND MAINTENANCE:

During each day of operation, the crew will inspect and monitor the fluids contained within the steel tank and visually monitor any release that may occur. Should a release, spill or leak occur, the NMOCD District 1 office Hobbs [575-393-6161] will be notified, as required in NMOCD's rule 19.15.29.8.

CLOSURE:

After plugging operations, fluids and solids will be hauled to and disposed of at Gandy Marley, permit # NM-0019.
