

1. Report all volumes on MMS OGOR reports.
2. Comply with NTL-4A requirements
3. Subject to like approval from NMOCD
4. All gas must be flared not vented.
5. Flared volumes will still require payment of royalties
6. Install gas meter on flare line to measure gas prior to flaring operations if it is not equipped as such at this time.
