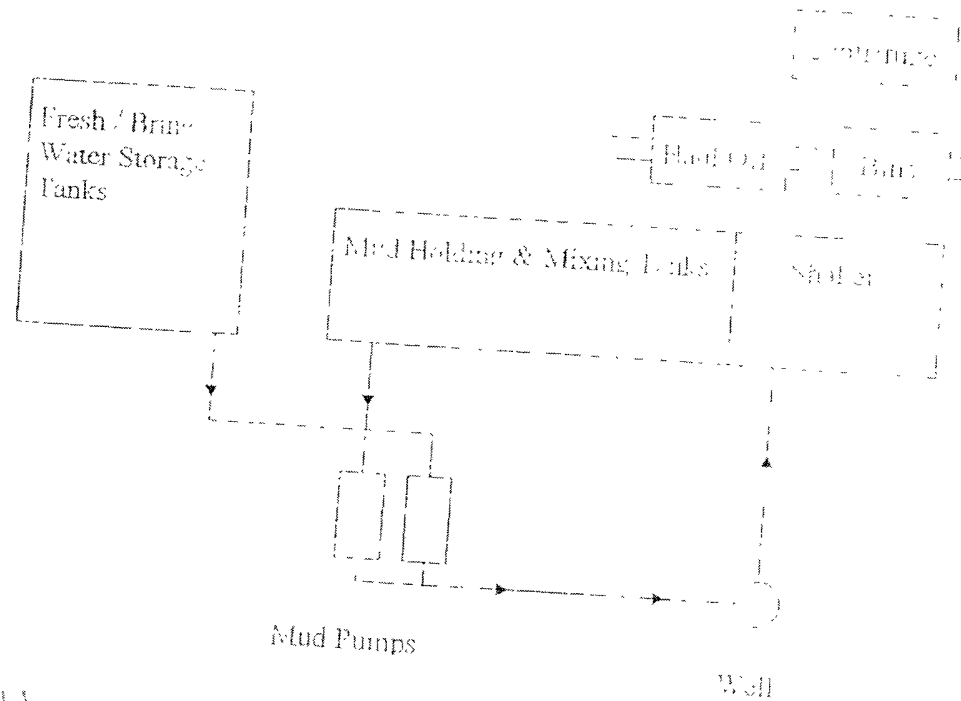
OPERATING AND MAINTENANCE PLAN
