PURSUANT TO A DIRECTIVE FROM BOTH THE BUREAU OF LAND MANAGEMENT (BLM) AND NEW MEXICO DEPARTMENT OF GAME AND FISH (NMDGF), THE SURFACE OWNER, YATES DRILLING COMPANY (YDC) WILL BE REQUIRED TO DEEP BURY THE CALICHE ROADWAY FROM THE NORTH SECTION LINE OF SAID SECTION, 660' TO THE LMY# 1 WELL SITE AND DEEP BURY THE CALICHE LOCATED ON THE WELL PAD IN ACCORDANCE WITH BLM & NMDGF GUIDELINES.

A MEETING WAS HELD ON WEDNESDAY, JUNE 16, 2010 IN MILNESAND, NM BETWEEN THE BLM, NMDGF AND YDC TO DISCUSS THE MATTER AND ESTABLISH THE GUIDELINES. FOLLOWING THE MEETING, THE NMDGF AND YDC MET ON THE WELL SITE AND FINALIZED THE RECLAMATION PROCEDURES.

AN ARCHAEOLOGICAL INVESTIGATION WAS CONDUCTED BY BOONE ARCHAEOLOGICAL SERVICES OF THE PROPOSED RECLAMATION AREA. NO CULTURAL RESOURCES WERE ENCOUNTERED. A COPY OF THIS REPORT HAS BEEN PROVIDED TO THE BLM AND NMDGF.

YDC IS CURRENTLY WAITING ON APPROVAL AND AN EXECUTABLE AGREEMENT FROM THE NMDGF TO THE WELL SITE TO PROCEED WITH THE RECLAMATION WORK.
