This well was originally permitted to have a 210' X 300' location with a 160' X 160' reserve pit. Fasken Oil and Ranch would like to eliminate the reserve pit and drill this well with a closed loop fluid system. The location size will be changed to 250' X 250' with no reserve pit. The drilled cuttings and fluid will be hauled off to an approved disposal facility. The closed loop system will consist of 2 frac tanks, a circular settling tank, and 2 roll off cuttings bins. The drilling rig is equipped with fluid holding tanks and a shale shaker. A revised location plat is attached.
