On 06/12/2010 we had a 70 bbl produced water release at the JC Federal #2 Tank Battery. 65 bbls was recovered with a vacuum truck immediatly after the release. The dimensions of the release were an 80' x 80' thin skim area on the pad location with a 3' x 120' channel leading to the pasture where there was a 10' x 15' pooling area off of the west side of the location.

We intend on performing assessment after submission and finalization of this sundry notice.
