6/29/2010 - TIH testing tubing to 5000 psi w/AD-1 packer, SN, and 112 jts IPC replacing blown joints while GIH. ND BOP & set packer in tension w/14 pts. NU WH. Release packer & circulate 60 Bbl pkr fluid. Reset packer in tension @ 3513'. No New perms were added.

7/20/2010 - Ran witnessed MIT on well prior to resuming injection. Test witnessed by NM OCD's Mark Whitacker. Test to 520 psi - OK for 30 minutes. Original chart for test was sent to NMOCD Division 1 office in Hobbs.

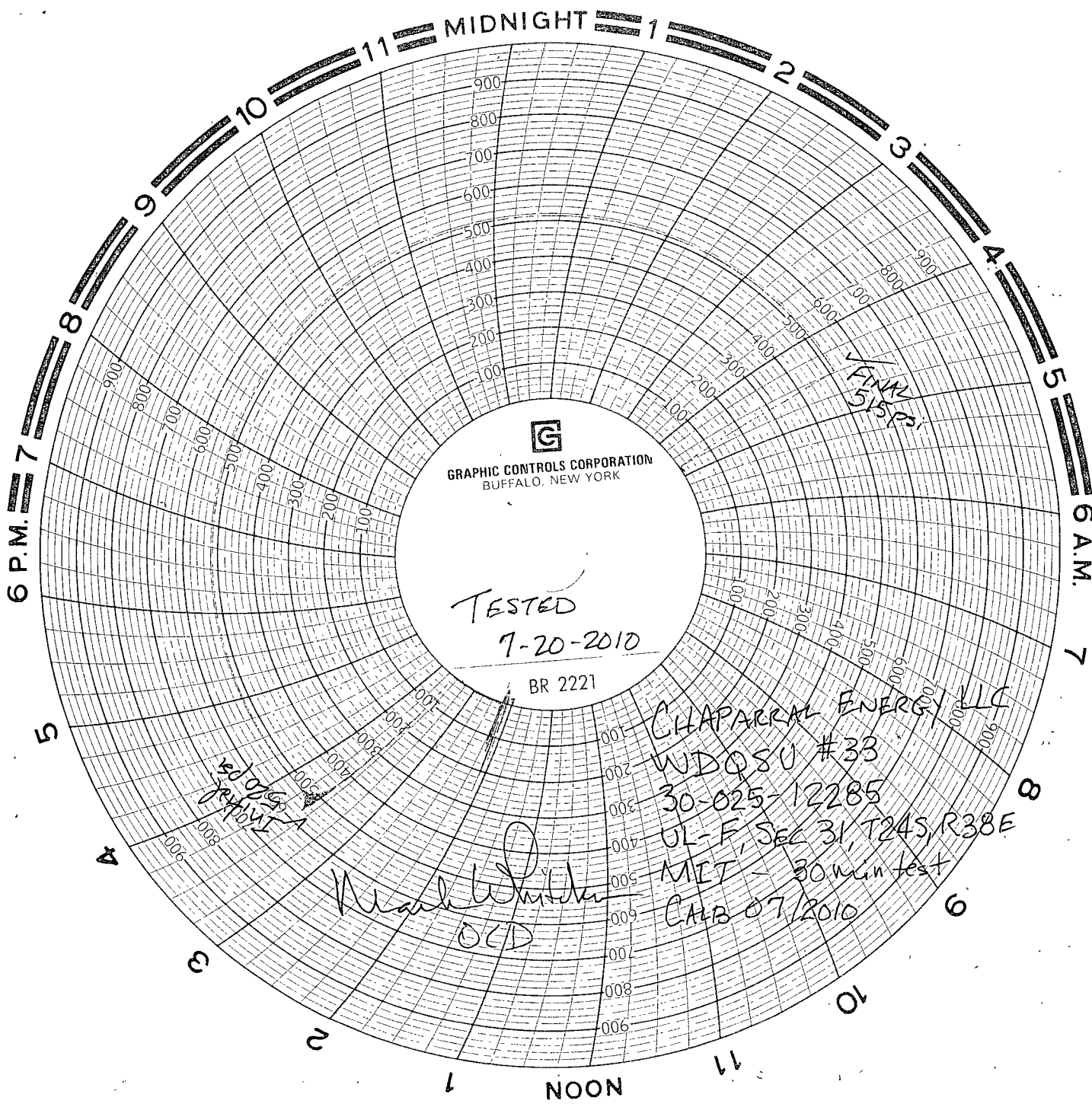
