

Tag fill @ 3491'. MIRU self contained reverse circ unit & power swivel. SDOWE. Clean out to BP @ 3508'. Drill out BP & clean out to 3763'. SDON. POOH w/bit & bottom hole assembly. RIH w/ AD-1 packer & 43 jts of 2-3/8" tubing. Set packer in tension @ 1308' after circ packer fluid into annulus. Test annulus OK. SDON. SIWHP 420 psi. Release pressure to tanker truck. NDBOP & NU WH. Reset Pkr @ 1308'. RDMO. On 6/29/2010 test well by flowing thru 42/64" choke well made 1 BO & 80 BWPD. Clean up location. Will flow well every month to bring well onto production flowline can be trenched to well.
