2. Re-perf Yates 3132-3164', 4 SPF @ 60 degree phasing.
3. RIH set packer @ 3081', acidize w/ 3000 gals 15% HCl 80/20 acid. Release packer and laydown.
3. RIH w/ 2-3/8" injection tubing and packer, set @ 3080'.
6. Pressure test to 630 psi, hold for 30 min, held ok.

This well has been returned to injection effective 5/22/10.

Pressured casing to 360 psi, dropped to 350 psi held for 30 mins, chart is attached. Mark Whitaker - OCD field rep witnessed test 7/16/10.

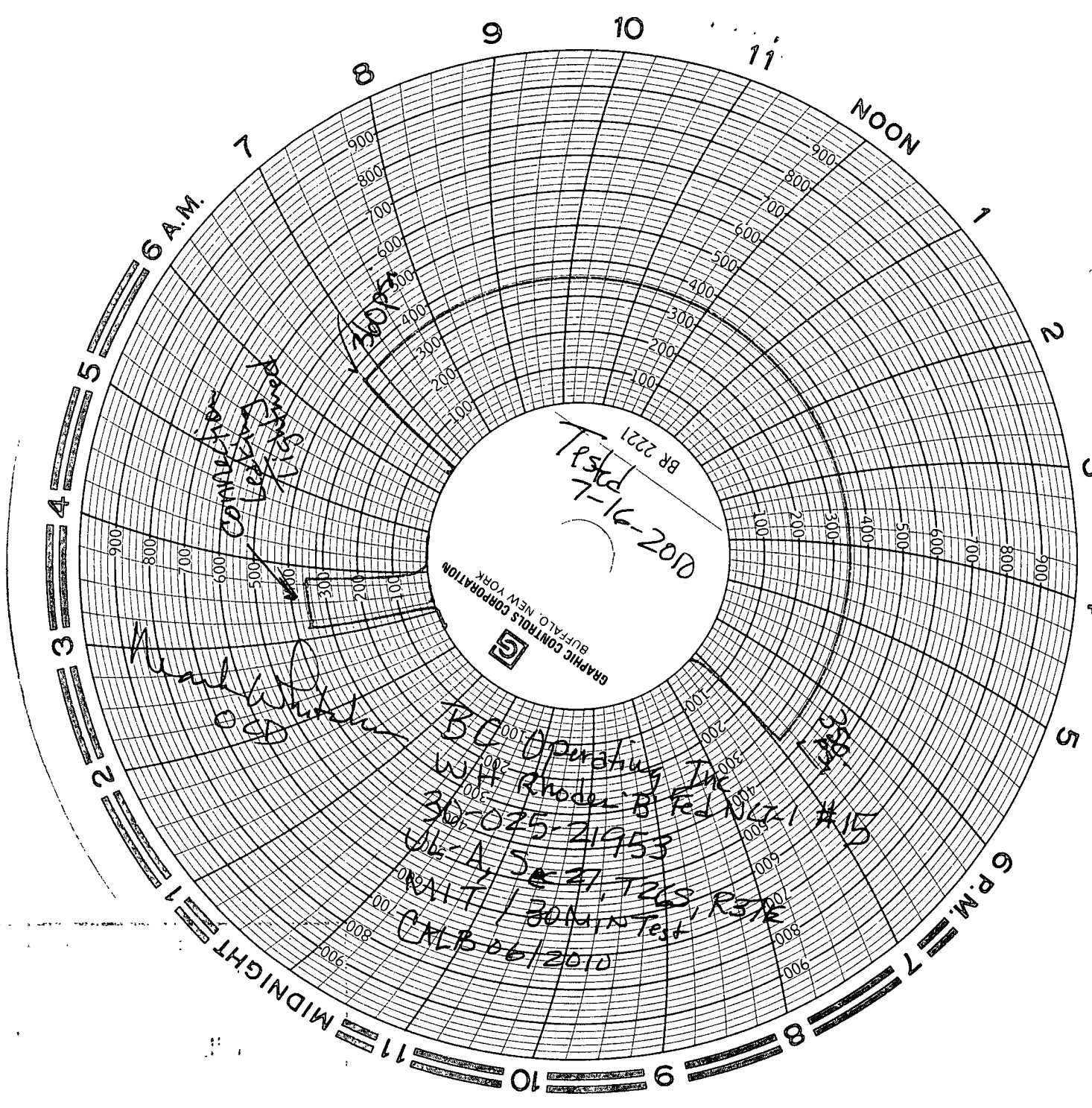
