RIH w/ wireline to check depth. (In September 2009, depth was found to be 3826' from GL)

RIH w/ tubing and packer. Set packer within 100' of top perforation (top perf is 3722' from GL)

Load backside and pressure up to 300 psi for 30 minutes to test casing integrity

If casing is good, we will RIH w/ 2-3/8" tubing (no packer), and set seating nipple about 30' below bottom perforation (bottom perf is 3796' from GL)

Run 3/4" D rods and 1-1/2" x 16' insert pump and install 114 pumping unit on well. Produced fluids will be pumped into newly set tanks at the location of the old Ingram Federal battery
