RIH w/ wireline to check depth.

RIH w/ tubing and packer. Set packer within 100' of top perforation (top perf is 3674' from GL)

Load backside and pressure up to 300 psi for 30 minutes to test casing integrity

If casing is good, we will RIH w/ 2-3/8" tubing (no packer), and set seating nipple about 30' below bottom perforation (bottom perf is 3715' from GL)

Run 3/4" D rods and 1-1/2" x 16' insert pump and install 114 pumping unit on well. Produced fluids will be pumped into newly set tanks at the location of the old Siete Federal battery
