Dear Operator.

During recent inspections of the Philmex wells located in Sec 26 T17S R33E, Lea County, New Mexico, the discovery of several idle electric power poles and electric line was noted. Hobbs District 1, OCD office is taking an active role in the elimination of idle power poles and overhead electric wire after the wells have been plugged and abandoned. If future operations do not require the existing power system, OCD would ask that Lea County Electric Coop be notified and request removal. OCD feels that the removal will eliminate future problems of downed poles and line due to weather conditions, grass fires or aging equipment.
