5/28/09 Set cmt retainer @ 6245' and squeeze Tubb perms from 6299' - 6432' w/ 250 sx class C cmt.
5/29 - 6/09/09 Tag cmt @ 6240'. Drill out cmt retainer @ 6245' and cmt. Fall out @ 6436'. Tag fill @ 6448'. CO fill.
DO cmt plugs from 6500' - 6550'. Retrieve RBP @ 6550'. DO cmt to new PBD @ 6718'. Circ clean.
6/09/09 Perf lower Drinkard @ 6654-63, 6664-75, 6680-90, 6698-6704' w/ 2 SPF, 72 holes.
6/10/09 Isolate and acid Drinkard from 6553' - 6643' and 6654' - 6704' w/ 4000 gals HCl.
6/10/09 Isolate and acid Blinbry from 5785' - 6050' w/ 2000 gals HCl.
6/12/09 RIH w/ injection packer to 5744'.
6/15/09 RIH w/ 2-3/8" injection string to 5744'.
6/16/09 Ran MIT and shut well in pending completion of injection lines.

7/06/09 Ran MIT for OCD. Witnessed by Sylvia Dickey. Still pending completion of injection lines.

2/01/10 Began injection in the Blinbry/Drinkard.

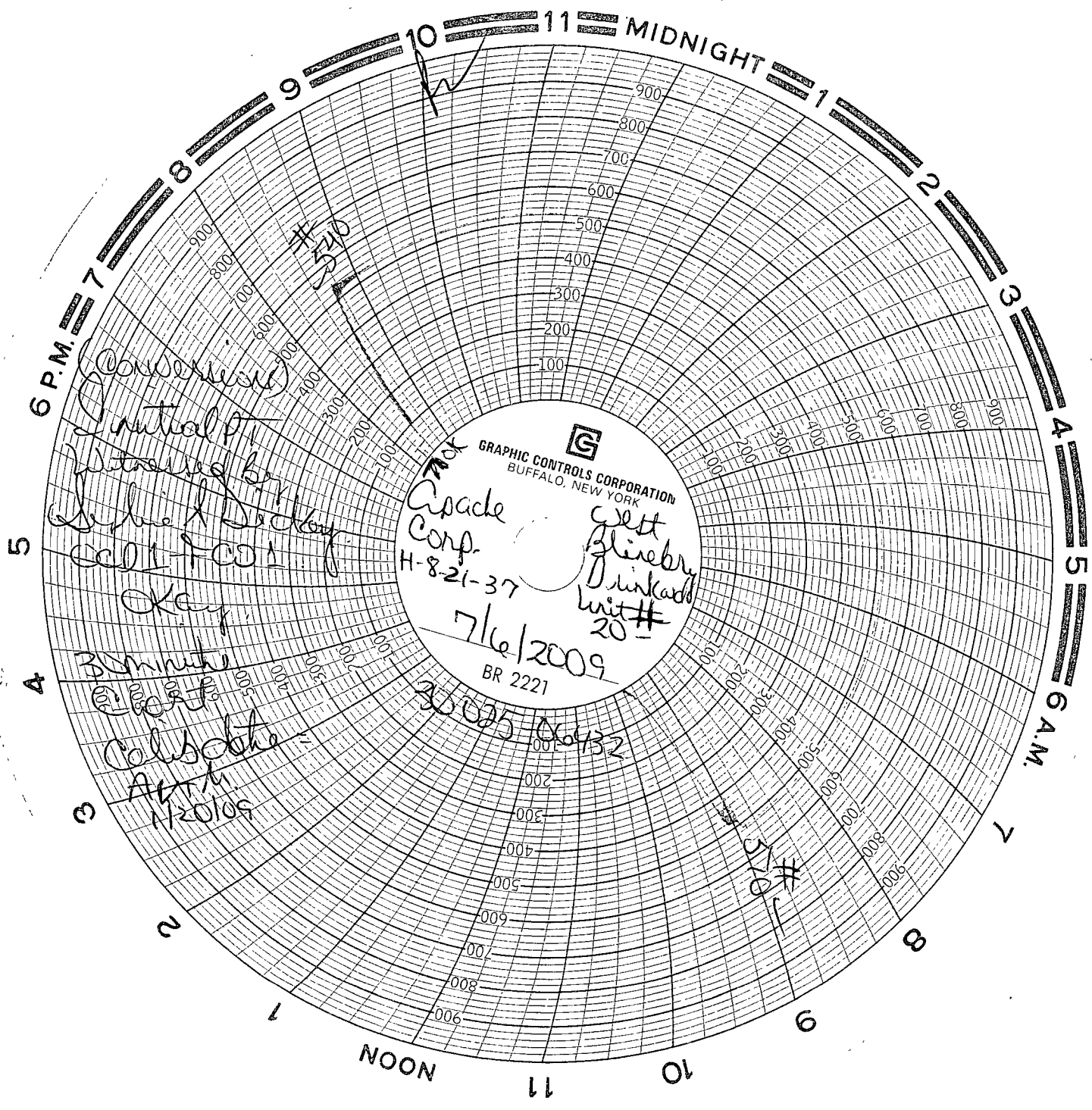
