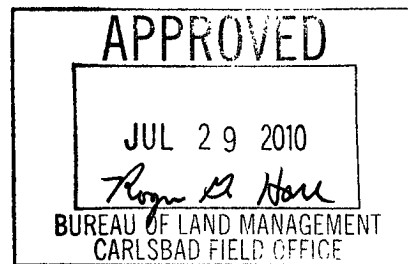

The Warren; Blinbry-Tubb formation is perforated @ 5841'-6278' and the Warren; Drinkard is perforated @ 6488'-6855'.

Allocation is based on a well test/subtraction method:

Warren; Blinbry-Tubb	85.4%
Warren; Drinkard	14.6%
