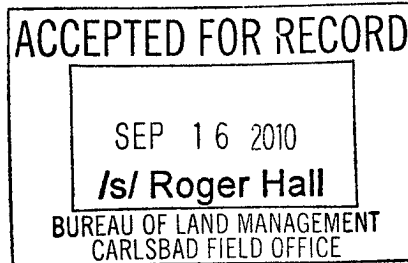

6/29/09 Perf Upper Drinkard @ 6496, 6508, 6516, 6526, 6537, 6573', 2 SPF, 12 holes.
Perf Lower Blinebry @ 5855-65, 5895-5900, 5915-5920, 5945-5950', 1 SPF, 25 holes.
6/30/09 Isolate and acid Drinkard from 6496' - 6573' and 6588' - 6674' w/ 4000 gals HCl.
Isolate and acid Blinebry from 5645 - 5837' and 5855' - 5950' w/ 4000 gals HCl.
7/02/09 RIH w/ injection packer to 5600'.
7/06/09 RIH w/ 2-3/8" injection string to 5600'.
7/06/09 Ran MIT and shut well in pending completion of injection lines.

10/29/09 Ran MIT for OCD. Witnessed by Mark Whitaker. Still pending completion of injection lines.

1/21/10 Began injection in the Blinebry/Drinkard.
