5/13/09 Acid Drinkard perms fr/ 6500' - 6630' w/ 4000 gals HCl.
5/14/09 Acid Blinebry perms fr/ 5799' - 6001' w/ 3000 gals HCl.
5/14/09 Set injection packer @ 5730'.
5/18/09 Set 2-3/8" injection tubing @ 5728', run MIT.
6/11/09 Run MIT, witnessed by OCD. Well shut in pending installation of injection lines.
8/03/09 Begin injection in the Blinebry/Drinkard.
