Within 48 hours should a spill occur, the NMOCD District 1 office in Hobbs (575-393-6161) will be notified. Please note that notifications may be made earlier to the district office should a greater release occur.

This is in keeping with the reporting requirements of NMOCD's rule 19.15.29.8

Closure:

After P&A operations, fluids will be hauled and disposed to the Sundance Disposal location. (permit number NM-01-0003)
