Equipment and Design:

Legacy Reserves Operating, LP will use a closed loop system for the plug and abandonment of this well. The following equipment will be on location:

- 1) 250 bbl steel tank

Operation and Maintenance:

During each day of operation, the rig crew will inspect and closely monitor the fluids contained within the steel tank and visually monitor any release that could occur. Should a release or spill occur, the NMOCD District 1 office in Hobbs, New Mexico (575-393-6161) will be notified, as required in NMOCD Rule 19.15.29.8.

After plugging operations are complete, all well and plugging fluids and solids waste will be hauled and disposed at Sundance Services (permit number NM-01-0003).
