1. Remove well head, anchors, flowline and any other debris from location
2. Remove caliche and any contaminated soil from location and access road
3. Put in 2'-3' caliche for barrier where needed
4. Put in 1'-2' clean topsoil as needed
5. Level and contour to surrounding area
6. Build an earthen berm at access to prevent vehicular traffic
7. Rip and seed all disturbed areas with BLM # 2 seed mix
