The Elvis #1 was converted to injection from 8/12/2010 to 8/23/2010. The following work was performed:

Drilled out CIBP, set 7" RBP at 13,840' & packer at 13,800', pumped 700 gal 15% HCL; move RBP to 13,800' and packer to 13,750', pumped 1300 gal 15% HCL; move RBP to 13,750' and packer to 13,700', pump 1000 gal 15% HCL; change out 437 jts 2-7/8" tubing at 13,613'. Set pump out plug at 13,650' and 7" 29# injection packer at 13,642'. Test 560# for 30 minutes.

Attached is the MIT chart, first disposal is pending pipeline construction.
