1. Remove well head, anchors, flowline, and any debris
2. Remove any contaminated soil from location and dispose at an authorized facility
3. Put in 1' to 3' caliche barrier and cap with 2' to 3' sand barrier
4. Contour and level to surrounding area
5. Built earthen berm to prevent vehicular traffic
6. All disturbed areas were reseeded using BLM seed mix # 2
