

Comments on Inspection: RESPOND TO COMPLAINT BY LANDOWNER. FOUND PASTURE EAST OF TANK BATTERY THAT SHOWED SPRAY OF OIL HAD COVERED VEGETATION. AREA IS FENCED TO PREVENT LIVESTOCK FROM ENTERING. FOUND DEPRESSION NORTH OF WELL AT EDGE OF LOCATION THAT IS BEING USED AS "TRASH PIT". AT THIS TIME IT CONTAINS A BROKEN CONCRETE BASE AND WOODEN BOARDS. 1-STEEL RING GASKET LAYING CLOSE BY. PLEASE REMOVE CONTENTS AND FILL IN AREA OR THIS PIT WILL BE CONSIDERED AN UNREGISTERED, UNLINED, UNFENCED PIT. (RULE 19.15.17.13.) THIS IS 1ST LETTER OF NON-COMPLINACE.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.

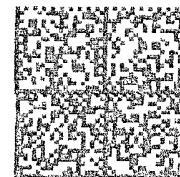
