1. Remove well head, anchors, flowline, and all other debris and installed dry hole marker.
2. Remove caliche and contaminated soil from 7/10 mile access road
3. Put in 1'-2' clean topsoil as needed
4. Level and contour to surrounding area
5. Build an earthen berm at access to prevent vehicular traffic
6. Rip and seed all disturbed areas with a BLM # 2 seed mix using an approved seeder
