The surface reclamation was completed on 9-15-2010 as follows:

- (1) Removed well head, anchors, flowline, and all other debris from location; installed Dry Hole Marker
- (2) Removed caliche and contaminated soil from location and access roads.
- (3) Put in 2-3 inches of caliche for barrier where needed.
- (4) Put in 1-2 inches of clean topsoil as needed.
- (5) Leveled and contoured to surrounding area.
- (6) Built earthen berms at all entrance locations to prevent vehicular traffic.
- (7) Ripped and seeded all disturbed areas with BLM #2 Seed Mixture using an approved seeder.
