10/7/2010 pick up 6 3 1/8 drill collars and bit, TAG at 4427, drill to 4481, pulled above perfs

10/8/2010 RU power swivel, RU Laydown machine, clean out fill to 4705

10/11/2010 Set work-string out, set production tbg in

10/12/2010 RU hydrotesters, tally tubing, pick up packer, TIH with tubing while hydrotesting, assembled tubing, set packer, RD hydrotesters lay down machine and floor, NDBOP, HUWH, Load and test casing to 550 psi, held for 30 min, charted results

10/13/2010 Pressure test well to 585# for 30 min, finished at 580#, OCD Maxey Brown passed well and signed chart, RU acid truck, pump 1000 gals of acid + 1000 gals of xylene mixed, displaced with 32 bbls of 10# brine, RD acid truck, cleaned location, Rig down pulling unit.
