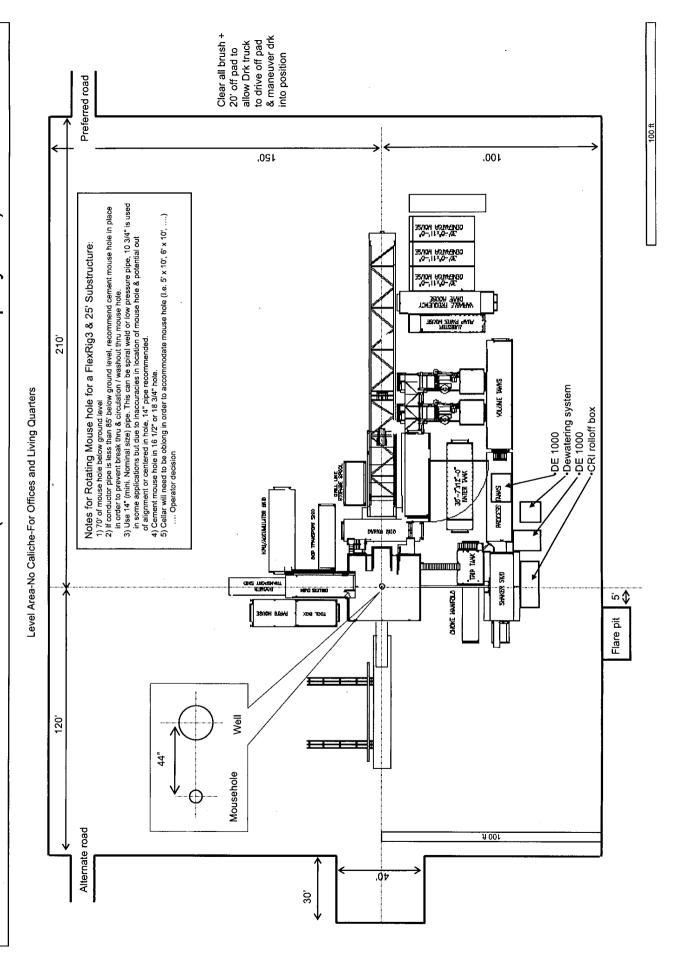

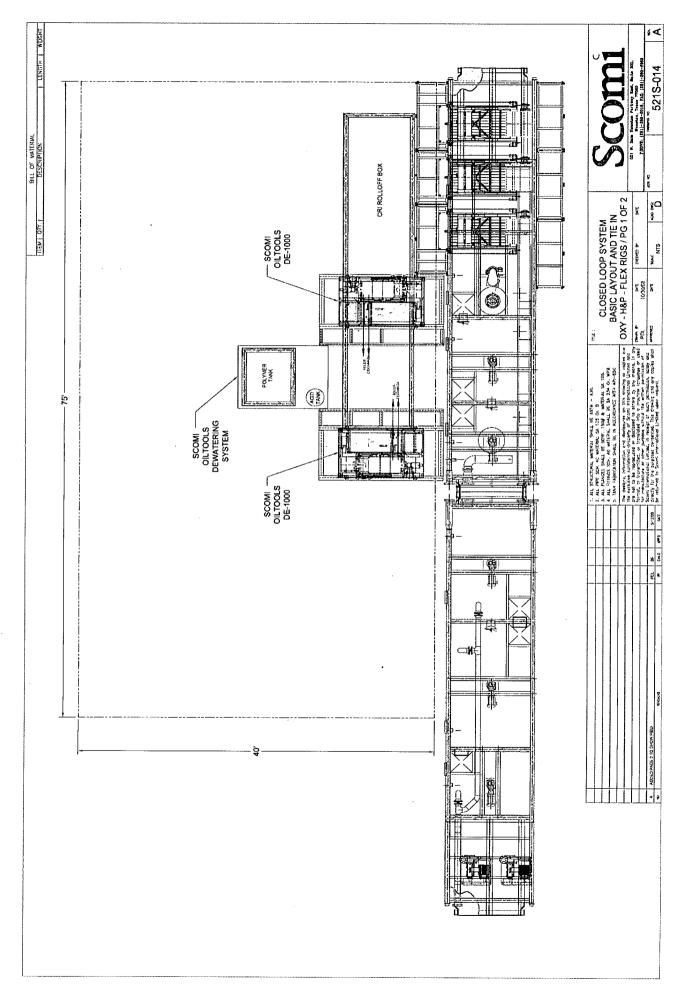

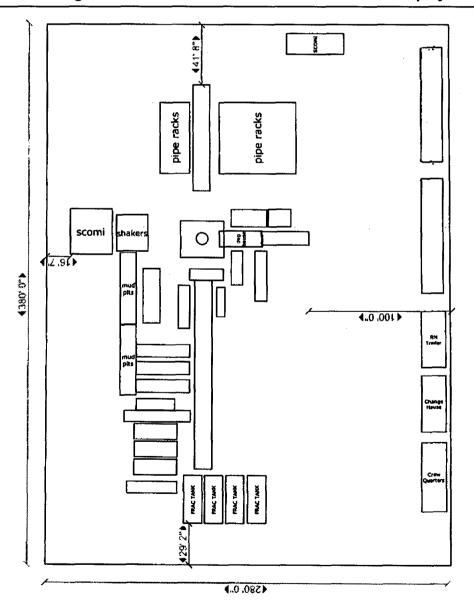
OXY FLEX III PAD (SCOMI Closed Loop System)
