13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. The well was drilled to a 5,968' KB depth on September 17, 2007 before being logged by Schlumberger (Density/Neutron/Laterolog/Cmt Vol Log). Following logs, drilling commenced in order to deepen the well to its final drill TD of 5,998 feet. New 5.50", 17#, J55, LT&C production casing was run to TD in this 7.875" hole and cemented to surface in a single stage with full returns as follows: BJ Services cemented with 925 sacks of 35:65 POZ Premium Plus 'C' LEAD cement with additives mixed at 12.8 #/gal and 1.89 Yield. 725 sacks of 50:50 POZ Premium Plus 'C' TAIL cement with additives followed which was mixed at 14.4 #/gal and a 1.25 Yield. The top plug bumped with 2500 psi, pressure released and the float held before setting the casing slips. An estimated 40 bbls of cement were circulated to surface with no fallback after pump shut down. United Drilling's Rig # 28 was released 4 hours later at 1800 hours on 9/19/07.

The well was bond logged on 9/25/07 without pressure and the Top of Cement was verified at surface.

A service rig was moved to location and completion operations were started on 9/26/07.
