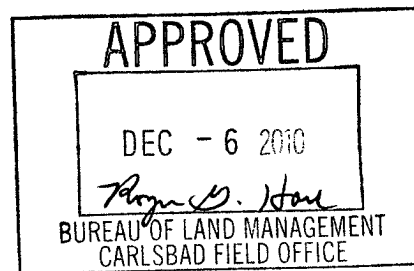

OGX requests a change in 13 3/8" casing as filed on the APD. This request is for an up-grade from H-40 to J-55. This is necessitated due to availability of J-55 vs. H-40.

The new casing will be: 17 1/2" hole, 0-820', 13 3/8", 48#, 8-R, STC J-55 New. The only change is the grade of casing. The J-55 exceeds the design criteria of the H-40.
