We plan to change the total TD (casing completion) to 13,460' (please see attached well schematic - Exhibit 12 revised).

The originally requested TD was 13,258' (based on offset well Grama Ridge Federal 8817 JVP #1, API# 30-025-30686, base of Morrow pick).

Our geologist estimates the Morrow Base to be 13,210' +/- . This TD will give us 250' +/- of cellar.

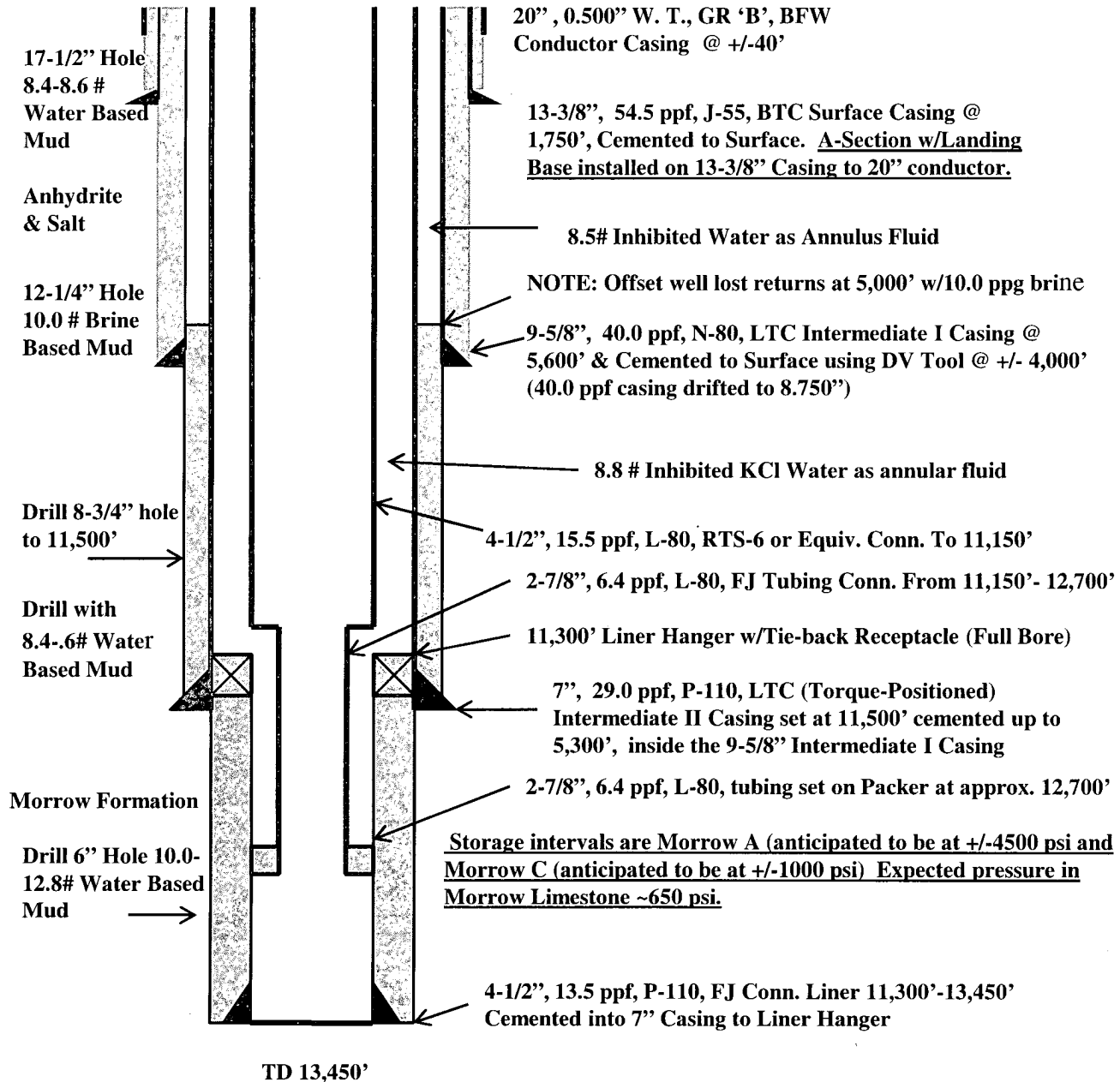
