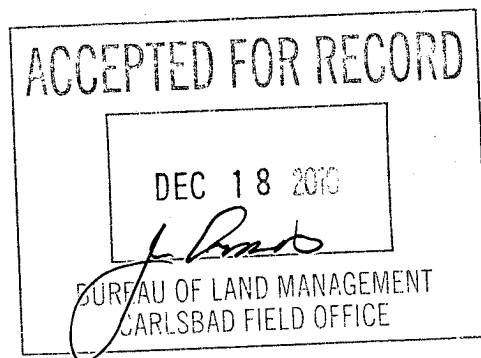

The Federal "26A" has been completed in the Corbin, Queen; South (Oil) and EK; Delaware pools and is currently down-hole commingled. The well was tested for a 24 hour period. The test method is pumping. The oil gravity is 39.0. The gas gravity is .785. Please see test data and allocation percentages listed below.

Test Date - 11-4-2010 - 132 bbls of Oil, 70 mcf, 25 bbls of water.

Allocation Percentages

South Corbin; Queen (Oil) - 26 bbs of Oil (20%), 18 mcf (25%), 19 bbls of water.
EK; Delaware - 106 bbls of Oil (80%), 53 mcf (75%), 6 bbls of water.
