Operations & Maintenance:

During each and every tour, the rig's crew will inspect and monitor closely the drilling fluids contained within the steel tank and visually monitor any spill which may occur. Within 48 hours should a spill, release or leak occur, the NMOCD District I Office in Hobbs will be notified. Notification may be made earlier to the district office should a greater release occur. This is in keeping with the reporting requirements of NMOCD's rule 116.

Closure:

After plug and abandonment operations, fluids will be hauled and disposed to the Controlled Recovery, Inc.'s (CRI) location. Should this facility not be available Sundance disposal is the alternative site.
